



DOLORS ALBEROLA POETRY PRIZE

Editorial DALYA announces the *Dolors Alberola Poetry Prize*, which aims to promote poetry reading from around the world. The spirit of this competition is to encourage the participation of writers on the basis of equality, regardless of nationality, gender or language.

Contest Rules:

ELIGIBILITY

1. The full-length manuscript or collection of poems may be written in any official language of the world.
2. Only one work per writer may be submitted. Translations of another author's work are not eligible.
3. Poems may be on any subject and in any form or style. Manuscripts must be typed and consist of 500 to 800 verses or lines.
4. The manuscript must be a new and original piece of work. The collection of poems must not have been published in any form or awarded previously.
5. There is no fee to enter, and there are no hidden costs for the entrants.

THE PRIZE

5.

a) **Winner:**

- 1) Translation into another European language.
- 2) Publication of the collection (bilingual edition).
- 3) 50 copies of the book.
- 4) Royalties on the publisher's edition.

b) **Finalists:**

- 1) Publication of the collection (Spanish edition).
- 2) 10 copies of the book.

3) Royalties on the publisher's edition.

HOW TO ENTER

7. The competition deadline for entry is on Wednesday, **15 January 2025**.
8. The work may be submitted via the links provided at **poetry.edalya.com** or on the Editorial DALYA site: **www.edalya.com**.
 - a) The document must contain a front page stating:
 - 1) The title of the collection.
 - 2) The name of the author or pseudonym.
 - b) The writer will receive an email acknowledging receipt of the entry.

ETHICAL CONSIDERATIONS

9. The organisation is committed to maintaining the utmost integrity of the contest.
 - a) To be certain that every manuscript receives the fairest evaluation, all manuscripts shall be submitted to the judges without any identifying material.
 - b) Bio or bibliography, awards, acknowledgments, and other identifying material shall be removed from the manuscript.
 - c) Judges shall recuse themselves from considering any manuscript where they recognize the authorship.

THE JUDGING PROCESS

10. Finalists. Works will be selected by Saturday, **28 February 2025**.
 - a) The writers of these works will be notified by email after selection.
 - b) The awarded writer must re-submit the work, including personal details (name, headshot, address, nationality, etc) and bio-bibliography in the front page.
11. Winner. The Jury will select the winner by Monday, **31 March 2025**.
 - a) The writers will be contacted after selection and the Jury's verdict will be announced on the website of Editorial DALYA (**www.edalya.com**), its social networks and the media.
 - b) The date of the resolution is tentative. It could be delayed if the provision of the final works to the jury requires extensive translation work.
12. Others Clauses.
 - a) The organization reserves the right not to award prizes if, in its sole discretion, it does not receive a sufficient number of qualified submissions.
 - b) The Jury's verdict is final.

- c) A finalist may reject the publication of the book. The decision must be communicated by e-mail within three months.

GENERAL CONDITIONS

13. Awarded entrants commit to signing a Publisher-Writer Agreement with the customary terms of Editorial DALYA.
- a) If it is not formalized, for any reason, the content of the contest rules will be considered as the agreement regarding the publication of the awarded books.
- b) Editorial DALYA commits to publishing the awarded works in twelve months, plus any period of force majeure.
14. Entrants are required to inform the organisation about the awards or publication of their works before the announcement of the Jury's verdict.
15. By entering the competition, each entrant agrees to be bound by the contest rules. No communication or correspondence will be entered into regarding the non-awarded works.
16. By entering the competition, entrants warrant that their works will not infringe any copyright or intellectual property rights, it will not violate any personal privacy regulations, and it does not violate the rights of any person or entity.
